**(1) Honorarium for Adjudicators and Viva-voce for the evaluation of Ph.D. thesis :**

- (a) Adjudication Honorarium :
- (i) For Indian Expert @ Rs.2,500/- : Rs. 2,500.00
- (ii) For Foreign Expert @ US \$ 75 : Rs. US \$ 75
- (b) Honorarium for Viva-voce Expert @ Rs.1,000/- : Rs. 1,000.00  
per candidate.

**(2) Fees for Ph.D. Programme :**

- (a) Registration Fees : Rs. 6,100.00
- (b) Course Work Fees : Rs. 5,000.00
- (c) Submission of thesis fees : Rs. 10,000.00

**(3) Extension Fees (if necessary) :**

- (i) Before Pre-submission Seminar @Rs.4,000/- in each. : Rs. 4,000.00
- (ii) After Pre-submission Seminar @Rs.3,000/- in each. : Rs. 3,000.00
