In partial modification of the Office Order bearing Memo No. VU/R/7EC-15/1044/2013 dated 30.08.2013 issued by this office earlier pertaining to introduction of the fees-structure for inspection regarding extension of affiliation of new subject(s)/course(s) at UG/PG level, setting up of new college, increasing intake capacity, permanent affiliation etc. for the undergraduate colleges affiliated to the Vidyasagar University, it has been directed to notify for general information that the Eighth Executive Council of Vidyasagar University in its meeting dated 08.09.2016 on the basis of the proposal submitted by the Inspector of Colleges of Vidyasagar University for conjoining some inspection fees has approved the said proposal and introduced the following fees-structure for this purpose. Please note that in addition to the normal fees, T.A./D.A. for the inspection teams will be provided by the concerned college/institution as decided by the Executive Council earlier.

| 05. | Self-financed B.Ed./M.Ed. B.P.Ed./M.P.Ed./LL.B./LL.M. College | Setting up of a new college/ introduction of new course. | Rs.30,000/- |
| 06. | Self-financed B.Ed./M.Ed./ B.P.Ed./M.P.Ed./LL.B/LL.M. College. | To increase intake capacity. | Rs.30,000/- at each go. |
| 07. | Self-financed affiliated Paramedical Courses. | To increase intake capacity | Rs.10,000/- at each go. |
| 08. | Govt.-aided General Degree College. | Permanent affiliation | Rs.10,000/- |
