REGULATIONS FOR MAINTENANCE OF STUDENTS' DISCIPLINE

Discipline is the best form of behaviour of people under certain rules and instructions. Discipline is related to mental, moral and physical training that produces orderliness, self control and obedience. Discipline refers to a systematic and methodic way of doing what ought to be done at the proper time with full faith and confidence under certain compulsion. Discipline thus ensures not only good actions, duty and devotion but living in peace & harmony with others too. Discipline is also necessary in institutions of higher learning to promote excellence.

- **1. Application**: Regulation of Discipline shall apply to all the students of Vidyasagar University for enforcement of discipline and good behavior within and outside the University campus.
- 2. Maintenance of Discipline: Heads / In-charge / Directors of the Departments / Centers shall look into the maintenance of well and disciplined behavior of the students. For cases requiring punishment as rustication / expulsion etc. the matter shall be referred to the Students' Disciplinary Committee.

3. Students' Disciplinary Committee : There shall be a bound of Discipline comprising the following members:

- *(i) The Dean, Faculty of Arts and Commerce*
- (ii) The Dean, Faculty of Science
- (iii) Two senior teachers of the University (to be nominated by the Hon'ble Vice Chancellor. One member must be a lady teacher), not below the rank of Professor
- (iv) The Dean of Students' Welfare DSW
- (v) The Controller of Examination
- (vi) Secretary, Faculty Councils for Postgraduate studies Member Secretary
- (vii) Hostel Warden(s)/ Superintendent
- (viii) Students representative (s) 2 (from outside the Students' Union) to be elected separately during the Student's Union election
- (ix) General Secretary of Student's Union or his nominee from VUSU

(x) Any other invitee (if required)

Note: One third of the members must be present to form the quorum

4. Definition of Terms of Punishment:

4.1 Conduct probation: A student found guilty of violating the rules and regulation of the University or of any act of undiscipline & misbehaviour by the Disciplinary Committee may be placed on close observation by the University authority for a specified period, which shall not be less than one month. During the period of conduct probation, a student shall not be allowed to -

(a) Represent the University in sports, cultural contests etc. either in the University or outside the University.

(b) Receive any Scholarship, Fellowship & Stipend. The loss entailed during the probation may be made permanent and no arrears shall be payable subsequently on its expiry.

A Student put on conduct probation on more than three occasions shall be expelled from the University with the approval of Hon'ble Vice-Chancellor or the Executive Council.

4.2 Rustication: It is the temporary removal from the rolls of the University / Hostel as a punishment for indiscipline. The minimum period of rustication shall be one semester in addition to the duration of the semester during which the order is passed.

or

It may be the permanent removal from rolls of the University /Hostel. An expelled student shall not be permitted to get fresh admission to the University in the next year(s).

5. Procedures relating to Rustication / Expulsion:

Before a student is rusticated / expelled the following procedure shall be followed:

(i) On receipt of the complaint against the conduct of the student, the Dean of Students' Welfare shall enquire into the matter immediately and place it before the Disciplinary Committee with the approval of the Hon'ble Vice-Chancellor not later than 3 working days from the date of receipt of the complaint. If the Disciplinary Committee is satisfied that there is a primafacie case of rustication / expulsion of the student, the student shall be informed in writing about the allegations against him / her or asked to appear before the Disciplinary Committee to explain why he / she should not be rusticated/ expelled.

- (ii) The accused students shall be asked to submit his / her explanation with 3
 (three) days from the date of issue of the intimation by the Dean, Students' Welfare.
- (iii) After receiving the explanation / answer, the Disciplinary committee shall examine the case minutely.
- (iv) If the committee is satisfied / convinced that this case is fit for rustication / expulsion, the Dean of Students' Welfare shall forward the recommendation of the Disciplinary committee for consideration of the Hon'ble Vice – Chancellor.

Further it is provided that

- (i) All Such cases shall be intimated to the Controller of Examinations and all concerned.
- (ii) The date of punishment shall be effective from the date of Notification issued by the Dean of Students Welfare.
- (iii) Any Disciplinary action taken by the said committee against a student shall be intimated to the student concerned / parents / guardians of the student.

6. Special Powers of the Hon'ble Vice- Chancellor:

Notwithstanding anything stated in these rules, the Vice – Chancellor shall have the authority to constitute an enquiry against any student (s) regarding his / her misconduct and to execute appropriate disciplinary action.

7. Discipline in General:

Any one of the following acts of a student shall come under the purview of disciplinary action -

- (i) Ragging in any form at the University campus.
- Misbehavior with other student(s)/ teachers / staff member of Vidyasagar
 University
- (iii) Breach of any standing rule of the University.
- (iv) Damage to University Property
- (v) Possessing fire-arms etc.
- (vi) Abuse of Internet / facilities.
- (vii) Gambling
- (viii) Moral turpitude

- (ix) Stealing
- (x) Consumption of drug and alcohol.
- (xi) Organising meeting by students inside the campus or assisting outsiders in organizing meeting inside the campus without the permission of the appropriate authority.

- (xii) Use of University premises for any purpose other than for which it is meant without permission of the concerned authority.
- (xiii) Misconduct in the University premises or in place recognized as University Property or site.
- (xiv) Any other cause / acts which may lower / hamper the image of the University.
- (xv) Other acts of indiscipline as considered by the appropriate authority.
- (xvi) Making irresponsible statement about the University before the media tarnishing the image of the University
 **Keeping identity card is compulsory for all the students inside the University campus.

8. Discipline in classroom / department:

(a) The Head of the Department / Center and the teacher(s) shall report to the Dean of Students' Welfare or to the authority of the University regarding the matter of breach of discipline which have come to his / her notice / knowledge and regarding the actions taken by him / her in this respect.

(B) Where Head of the Department/ Center or TIC has the opinion that a heavier punishment to be imposed is necessary, he / she shall report the case to the Dean of Students' Welfare with his/her recommendations in writing and the Dean of Students' Welfare may take appropriate action as deemed fit or forwarded the matter before the Disciplinary Committee.

9. Discipline in examination:

As per rules specified in Examination regulation of the University.

10. Discipline in Hostel:

These shall be covered under the Hostel rules.

11. Discipline in play Ground:

These shall be covered under the rules framed / stipulated for sports and games.

12. Disciplinary action / Punishment:

Warning, Fine, Conduct Probation, Rustication Expulsion etc. shall be exercised as punishment as per the merit of the case.

12.1 The Student must follow the discipline strictly as described in clauses mentioned above. Violation of any clause by any Student will be subjected to the following punishment:

12.2. Discipline in General: Student must follow strictly the discipline as described in clause 7 herein above. Violation of any clause by any student will be subjected to the following punishment:
