Sub: - IGST Exemption/ Concession under GST on purchase of Equipments covered under DSIR certification

It is notified for information of all concerned that as per discussion in the GST Council meeting held on 18th /19th May, 2017, the Central Board of Excise and Customs, Department of Revenue, Ministry of Finance, Government of India has confirmed that the University comes under IGST Exemption/ Concession under GST on purchase of Equipments covered under DSIR certification. The extract of the resolution of the GST Council meeting is given below:

I. **Multilateral/Bilateral Commitments- Imports by Privileged Persons, Organizations, Authorities and Foreigners.**

Sl. No.	Present Customs Notification No. and date	Gist of the Notification
17	51/96- Customs, dated- 23.07.1996	Exemption to research equipments imported by: (a) Public funded research institutions or a University or an Indian Institute of Technology or Indian Institute of Science, Bangalore or Regional Engineering College, other than a Hospital, Subject to, inter alia, registration with the DSIR.

Further to add that, our University is registered with the Department of Scientific & Industrial Research (DSIR) for purposes of availing customs duty exemption in terms of Government Notification No.- 51/96- Customs, dated- 23.07.1996 (Copy enclosed).

Hence, the University is exempted from paying GST on purchase of Equipments covered under DSIR certification.

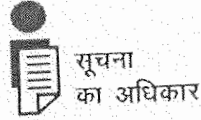
