**NOTIFICATION**

In continuation to the Notification bearing Memo No. VU/R/Noti./C149/2016 dated 19.04.2016 issued by this office earlier pertaining to different fees for Ph.D. Programme of Vidyasagar University along with the honorarium of adjudicators and viva-voce experts, it is hereby notified again for general information that the Eighth Executive Council of Vidyasagar University in its meeting dated 28.08.2017 on the recommendation of the Board of Research Studies of Vidyasagar University taken in its meeting held on 17.08.2017, has revised the fees for Ph.D. programme only. Other fees like, Honorarium for Adjudicators and Viva-Voce Experts, Extension fees etc. of the aforesaid notification dated 19.04.2016 will remain unchanged. The revised fees for Ph.D. programme and the Honorarium and others related with the Ph.D. programme are as follows :

(1) **Honorarium for Adjudicators for the evaluation of Ph.D. thesis & Viva-Voce Experts :**

(a) Adjudication Honorarium :

(i) For Indian Expert @ Rs.2,500/- : Rs. 2,500.00  
(ii) For Foreign Expert @ US \$ 75 : Rs. US \$ 75

(b) Honorarium for Viva-voce Expert @ Rs.1,000/- per candidate. : Rs. 1,000.00

(2) **Fees for Ph.D. Programme :**

(a) Registration Fees : Rs. 6,100.00  
(b) Course Work Fees : Rs. 7,000.00 (Revised)  
(c) Submission of thesis fees : Rs. 12,000.00 (Revised)

(3) **Extension Fees (if necessary) :**

(i) Before Pre-submission Seminar @ Rs.4,000/- in each. : Rs. 4,000.00  
(ii) After Pre-submission Seminar @ Rs.3,000/- in each. : Rs. 3,000.00

All concerned related with the Ph.D. Programme are being informed accordingly. The fees as revised by the Executive Council will come into force with immediate effect.
