NOTIFICATION

It is hereby notified for general information that the Eighth Executive Council of Vidyasagar University in its meeting held on 03.01.2020 on the recommendation of the Canteen Supervision Committee taken in its meeting held on 27.12.2019 regarding revision of the existing rate of meals of the University Canteen, has revised the rate of Students' Subsidised Lunch, University subsidy and various category of meals as follows:

- (1) <u>Students' Subsidised Lunch:</u> From Rs.30/- (Rupees Thirty) only to Rs.32/-(Rupees Thirty Two) only.
- (2) <u>University subsidy</u>: From Rs.7/- (Rupees Seven) only to Rs.8/- (Rupees Eight) only.
- (3) Various Category of Meal:
 - (a) <u>Fish Meal</u>: From Rs.55/- (Rupees Fifty Five) only to Rs.60/- (Rupees Sixty) only. Minimum 60-70 Gm. Fish will be provided.
 - (b) Egg Meal: From Rs.40/- (Rupees Forty) only to Rs.45/- (Rupees Forty Five) only.
 - (c) Veg Meal: From Rs.35/- (Rupees Thirty Five) only to Rs.40/- (Rupees Forty) only.
 - (d) <u>Chicken Meal</u>: From Rs.60/- (Rupees Sixty) only to Rs.65/- (Rupees Sixty Five) only. Minimum 100-120 Gm. Chicken will be provided.

The above rate chart of meals so revised would be applicable both for DULUNG Canteen and ARANAYAK Guest House of Vidyasagar University with immediate effect.
