It is hereby notified that with reference to the recent Advisory of the University Grants Commission, New Delhi and the orders issued by the State Government in view of the pandemic situation due to the outbreak of COVID -19 and the ongoing Lockdown, the Examination Department of the University decided that the institutions offering self financed professional Post Graduate Courses of Vidyasagar University, including M.B.A, MSW and LL.M, may decide to hold online semester examinations for the year - 2020 only as a special case, if they so desire (optional), at their own expenses. The decision of the Examination Department has been subsequently ratified in the Executive Working Committee at its meeting held on 11.05.2020. Such examinations have to be held strictly as per University rules and the University has to be informed regarding all the details of such examination including Moderation of question papers and external agency/ agencies, if any, deployed for holding of any such online examinations. The detailed schedule, mode of examination, and other related information may kindly be sent to the Controller of Examinations and the Secretary, Faculty Councils for Postgraduate Studies of this University in due course.

The Chairmen/Directors/Principals/Teacher-in-Charges of all institutes/ colleges running postgraduate professional courses of Vidyasagar University in the self-finance mode are being informed accordingly and requested to do the needful at the earliest


