## **FESTIVAL ADVANCE 2025**

#### Ref: VU/Fin/Fest Adv/ 1340 /2025

This is for information of all concerned that the University Authority has kindly agreed and approved payment of Interest Free Festival Advance like previous years for all the eligible university employees from its own resources subject to the following terms and conditions given below:

Date: 13/03/2025

- All employees in permanent and substantive post may receive Rs. 22000/- (Maximum)
- 2 All Wholetime Contractual employees whose monthly consolidated salary exceeds Rs. 18000/- may receive Rs. 22000/-
- All Wholetime Contractual employees whose monthly consolidated salary exceeds Rs. 10000/- but less than Rs. 18000/- may receive Rs. 18000/-
- 4 All other Wholetime Contractual employees whose monthly consolidated salary is less than Rs. 10000/- may receive Rs. 10000/-
- 5 Contractual Hostel Employees may receive Rs. 10000/-
- The Advance will be first adjusted with bonus (as per G.O.) if eligible, and rest will be recovered from monthly salary in 10 equal monthly installment starting from salary for the month of **November**, 2025.
- The employees who will retire before 1<sup>st</sup> November, 2025 will not be allowed any festival advance.
- All Teachers, Non-teaching employees and officers drawing gross pay exceeding Rs. 60000/- per month are requested to kindly refrain from applying for festival advance in the greater interest of the financial health of the university.

The last date of receiving application for festival advance in the enclosed proforma by the office of the undersigned is 19<sup>th</sup> March 2025 for all Muslim employees and for rest employees 25<sup>th</sup> August, 2025.

No application will be considered after the due date, hence no request be made.
