NOTIFICATION

In continuation to the Notification bearing Memo No. VU/R/Noti./8EC-24/C0171/2019 dated 29.04.2019 & Notification bearing Memo No. VU/R/Noti./C0076/2021 dated 08.03.2021 issued by this office earlier regarding fixation of different fees for Ph.D. Programme of Vidyasagar University alongwith the honorarium of Adjudicators including Viva-voce Experts and subsequently as decided by the Board of Research Studies (BRS) of Vidyasagar University further in its Twelfth (12th) meeting held on 24.06.2025 vide Misc. Item No. 27(I) based on the proposal submitted by our Ph.D. Cell and duly approved by the Hon'ble Vice-chancellor, the said fees for this purpose has been revised as follows :

■ **Fees for Ph.D. Programme :**

- Registration Fees - Rs.12,100/- (Rupees Twelve thousand one hundred) only.
- Course Work Fees - Rs.10,000/- (Rupees Ten thousand) only.
- Submission of Thesis Fees - Rs.20,000/- (Rupees Twenty thousand) only.
- Extension Fees, if required - Rs.6,000/- (Rupees Six thousand) only.
- Re-registration Fees - Rs.8,000/- (Rupees Eight thousand) only.

■ **Honorarium for Adjudicators for the evaluation of Ph.D. thesis & Viva-voce Experts :**

- (a) **Adjudication Honorarium :**
- For Indian Expert - Rs.3,500/- (Rupees Three thousand five hundred) only.
 - For Foreign Expert - US \$ 125 (One hundred twenty five US Dollar)
- (b) Honorarium for Final Viva-voce Expert - Rs.3,500/- (Rupees Three thousand five hundred) only.

All concerned related to the Ph.D. Programme are being informed accordingly and the fees for Ph.D. Programme and Honorarium for Adjudicators & Viva-voce Experts as enhanced by the BRS will come into force with immediate effect.
