This is for information of all concerned that the University Authority has kindly agreed and approved payment of Interest Free Festival Advance like previous years for all the eligible university employees from it's own resources subject to the following terms and conditions given below:

- 1 All employees in permanent and substantive post may receive Rs. 22000/- (Maximum)
- 2 All Wholtime Contractual employees whose monthly consolidated salary exceeds Rs. 18000/- may receive Rs. 22000/-
- 3 All Wholtime Contractual employees whose monthly consolidated salary exceeds Rs. 10000/- but less than Rs. 18000/- may receive Rs. 18000/-
- 4 All other Wholtime Contractual employees whose monthly consolidated salary is less than Rs. 10000/- may receive Rs. 10000/-
- 5 Contractual Hostel Employees may receive Rs. 10000/-
- 6 The Advance will be first adjusted with bonus (as per G.O.) if eligible, and rest will be recovered from monthly salary in 10 equal monthly installment starting from salary for the month of November, 2024.
- 7 The employees who will retire before 1st November, 2024 will not be allowed any festival advance.
- 8 **All Teachers, Non-teaching employees and officers drawing gross pay exceeding Rs. 60000/- per month are requested to kindly refrain from applying for festival advance in the greater interest of the financial health of the university.**

The last date of receiving application for festival advance in the enclosed proforma by the office of the undersigned is **2nd April 2024 for all Muslim employees** and for rest employees **13th September, 2024.**

No application will be considered after the due date, hence no request be made.
