ORDER

To reduce the noise pollution in public places/open area restrictions on the use of loud speakers/public address system and sound producing instruments will be followed strictly as mentioned in Notification No. EN/3346/T-IV-6/001/2007 (Pt. II) dated 29.12.2009 of the Department of Environment, Govt. of West Bengal, Writers' Buildings, "G" Block, (2nd Floor), Kolkata-01.

1. A loud speaker or a public address system shall not be used except after obtaining written permission from the competent authority i.e. the Sub-Divisional Officer of the district of Paschim Medinipur.
2. A loud speaker or a public address system or any sound producing instrument or a musical instrument or a sound amplifier shall not be used at night time except in closed premises for communication within, like auditorium, conference rooms, community halls, banquet halls or during a public emergency.
3. A loud speaker or a public address system shall be used only from 6:00 AM to 10:00 PM in open area after obtaining necessary permission from the competent authority.
4. Use of loud speakers in public places / open area strictly prohibited before 3 days of commencement of Secondary & Higher Secondary Examination and till completion of such examination.
5. Permissible ambient noise level as notified by the Government of India under Environment (Protection) Act, 1986 should be maintained during the use of microphones. During the use of microphone in open air, sound limiter should be attached with amplifier for regulating noise level.

Head of the institutions, like hospitals, nursing homes, courts, universities, colleges and schools are also hereby informed to install a display board in a conspicuous place mentioning thereto that such area is a 'Silence Zone' and no one is allowed to use loud speakers in open air or use any kind of vehicular horn in the 'Silence Zone' area and also mentioning thereto is strictly prohibited

HENCE, all the aforementioned authorities are now hereby directed to implement the aforementioned prohibition, regulation and direction meticulously and in case of any violation, all implementing authorities should also initiate legal action in accordance with law.

This order will take immediate effect.


