The students who want to review can now apply by filling up the application from through online along with requisite fees.

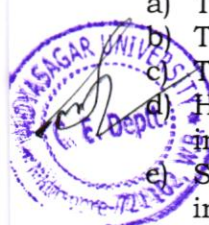
