- (v) four External Experts (not below the rank of Professor) to be nominated by the Hon'ble Vice-chancellor (preferably two from each faculty) ;
 - (1) Professor Debnarayan Bandyopadhyay, former Vice-chancellor of Bankura University ;
 - (2) Professor Sudakshina Gupta, Department of Economics, University of Calcutta ;
 - (3) Professor Ashutosh Ghosh, former Vice-chancellor of Rani Rashmoni Green University ;
 - (4) Professor Sourangshu Mukhopadhyay, Hon'ble Vice-chancellor, Mahatma Gandhi University, Purba Medinipur ;
- (vi) the Registrar as Member Secretary.

All members of the Board of Research Studies are being informed accordingly and requested to do the needful in this regard. The BRS so constituted will function for a period of four (04) years from the date of constitution of the same.
